## Item 1. Security and Issuer.

This Amendment No. 1 to the Schedule 13D that was filed on April 26, 2019 relates to the Class A common shares, par value \$0.01 per share (“**Class A Common Shares**”), of Global Ship Lease, Inc., a Marshall Islands corporation (the “**Issuer**”), having its principal executive offices at c/o Global Ship Lease Services Limited, 25 Wilton Road, London SW1V 1LW, United Kingdom.

## Item 2. Identity and Background.

Item 2 of the Schedule 13D that was filed on April 26, 2019 is hereby amended and restated in its entirety as follows:

This Schedule 13D is being filed on behalf the following:

Management Investor Co., a Marshall Islands corporation (“**Management Investor**”);

Management Investor Holding Inc., a Marshall Islands corporation (“**Management Investor Holding**”), and the sole shareholder of Management Investor;

Shipping Participations Inc., a Marshall Islands corporation (“**Shipping Participations**”), a majority shareholder of Management Investor Holding;

Shipping Investments Treasurer Inc., a Marshall Islands corporation (“**Shipping Investments Treasurer**”), and the sole shareholder of Shipping Participations; and

Georgios Giouroukos, a citizen of Greece and the sole shareholder of Shipping Investments Treasurer (“**Mr. Giouroukos**”, and together with Management Investor, Management Investor Holding, Shipping Participations, and Shipping Investments Treasurer, the “**Reporting Persons**”).

As of the date of this filing, Management Investor and Management Investor Holding do not beneficially own any Class A Common Shares.

As of the date of this filing, Shipping Participations, Shipping Investments Treasurer and Mr. Giouroukos may be deemed the beneficial owners of approximately 8.4% of the Issuer’s outstanding Class A Common Shares.

The principal business of each of Management Investor, Management Investor Holding, Shipping Participations and Shipping Investments Treasurer is acting as a holding company for investments in the shipping industry. Mr. Giouroukos is the Executive Chairman of the Issuer, the Founder, Managing Director, and majority beneficial owner of Technomar Shipping Inc., and the sole beneficial owner of ConChart Commercial Inc.

The principal business address and principal office address of each of the Reporting Persons is c/o Technomar Shipping Inc., 3-5 Menandrou Str., Kifisia 14561, Athens, Greece.

The identity, present principal occupation/employment, citizenship and business address of the sole director of each of the Reporting Persons (the “**Principal**”), other than Mr. Giouroukos, are set forth below. None of such Reporting Persons has any executive officers.

The Reporting Persons, and to the best of their knowledge, the Principal, have not, during the last five years, been convicted in any criminal proceeding (excluding traffic violations or similar misdemeanors).

The Reporting Persons, and to the best of their knowledge, the Principal, have not, during the last five years, been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, Federal or state securities laws or finding any violation with respect to such laws.

Item 3. Source and Amount of Funds or Other Consideration.

Item 3 of the Schedule 13D that was filed on April 26, 2019 is hereby amended to include the following:

Shipping Participations acquired an additional 137,932 Class A Common Shares directly from the Issuer in an underwritten public offering pursuant to the Issuer's registration statement on Form F-1 (File Nos. 333-233198 and 333-233963) that closed on October 1, 2019 (the "**Offering**"). Shipping Participations acquired these shares at the public offering price of \$7.25 per share using funds from working capital. Following the Offering, the Issuer had 17,556,738 Class A Common Shares outstanding.

On February 20, 2020, Management Investor (through Management Investor Holding) distributed to its beneficial shareholders an aggregate of 1,969,188 Class A Common Shares, through a special stock dividend, pro rata in accordance with the percentage ownership of each such shareholder in Management Investor Holding (the "**MI Special Dividend**"), resulting in Shipping Participations directly acquiring an additional 1,335,404 Class A Common Shares.

Item 4. Purpose of Transaction.

There are no material changes from the Schedule 13D that was filed on April 26, 2019.

Item 5. Interest in Securities of the Issuer.

Item 5 of the Schedule 13D that was filed on April 26, 2019 is hereby amended and restated in its entirety as follows:

(a, b) As of the date of this filing:

Following the MI Special Dividend, Management Investor and Management Investor Holding do not beneficially own any Class A Common Shares.

Shipping Participations, Shipping Investments Treasurer, and Mr. Giouroukos may be deemed to be the beneficial owners of 1,473,336 Class A Common Shares, representing approximately 8.4% of the Issuer's outstanding Class A Common Shares. Shipping Participations, Shipping Investments Treasurer, and Mr. Giouroukos have the shared power to vote and dispose of these Class A Common Shares.

To the best of the Reporting Persons' knowledge, the Principal does not beneficially own any Class A Common Shares.

Except as set forth in this Item 5, none of the Reporting Persons beneficially owns any Class A Common Shares.

(c) Except as set forth in Item 3, no transactions in the Class A Common Shares were effected by the Reporting Persons during the past 60 days.

(d) No other person is known to have the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of, any of the Class A Common Shares beneficially owned by the Reporting Persons.
